11. Compile Sect 46 Report and Revise & Restructure Performance Scorecards

The Sect 46 Report and Revised & Restructured Performance Scorecards were due for submission to the Auditor-General by the 31<sup>st</sup> August 2010. Because of the urgency of the matter the Accounting Officer negotiated directly with Charmaine van Schalkwyk Consulting. The firm is well known and has the best insight in the doings of the municipality.

### **Recommendation:**

<u>That Charmaine van Schalkwyk consulting be appointed to Compile the Sect 46 Report</u> and Revise & Restructure the Performance Scorecards at a cost of R 83 676.00.

4. Contract No. 41/2009: The Construction of Gravel Roads in Wards 7, 8, 9 and 12 in Senqu Municipal Area, Phase 3: Variation Order No. 1.

Council has approved the project. Available budget = R 14 500 000.00. Engineer Estimate a saving of +/- R 1 352 496.10 on budgeted amount.

# **Recommendation:**

That Variation Order No.1 amounting R 175 856.40 be approved.

5. Contract No. 41/2009: The Construction of Gravel Roads in Wards 7, 8, 9 and 12 in Senqu Municipal Area, Phase 3: Variation Order No. 2.

Council has approved the project. Available budget = R 14 500 000.00. Engineer Estimate a saving of  $\pm$  1 352 496.10 on budgeted amount.

#### **Recommendation:**

That Variation Order No.1 amounting R 186 732.00 be approved.

6. Contract No. 38/2009: Construction of Roads & Storm Water Infrastructure at Kwezi-Naledi Township in Lady Grey: Variation Order No. 2.

This Variation Order is not an additional scope of works but address the change in prioritizing the construction of roads and storm water which was identified during the construction stage of the project. It has no financial implications.

# **Recommendation:**

That Variation Order No. 2 be approved.

7. Contract No. 38/2009: Construction of Roads & Storm Water Infrastructure at Kwezi-Naledi Township in Lady Grey: Variation Order No. 2.

Due to heavy storm water run-offs in the area, the storm water concrete channels size have been increased from the original size of 600mm width x 100mm thick to 1200mm x 150mm thick. These changes in design have cost implications on the total cost of the works under the storm water section. Funding of this variation order will be sourced from the roads section, which will amount to R 84 340.00 of the Bill of Quantities.

## **Recommendation:**

That Variation Order No.3 be approved.

8. Contract: Phase 3: Additional Office Accommodation: Extension of Time Claim No.1.

The Client requested a concrete roof slab be built above the Strategic Planning Department (north wing) to accommodate future first floor office additions. The roof trusses over this section were already erected at this stage and had to be removed to

cast the new concrete roof slab. ImpenduloDesign Architects (IDA) considers a 3 weeks delay as reasonable. Original Practical Completion date 15/12/2010 – Revised Practical Completion date now 28/1/2011.

# **Recommendation:**

That the Extension of Time Claim No.1 be approved.

### 9. Contract: Phase 3: Additional Office Accommodation: Extension of Time Claim No.2.

The specialist acoustic ceiling is installed between the purlins and roof sheeting, which means roof sheeting and ceiling have to be installed simultaneously. Due to this work method, the Contractor could not commence roof sheeting on the anticipated date. ImpenduloDesign Architects (IDA) support the Contractors claim for delay, resulting in a nett delay of 11 days. First Revised Practical Completion date 28/1/2011 – Revised Practical Completion date now 14/2/2011.

# 10. Tenders 15/2010A and 15/2010B: Musong Road

2<sup>nd</sup> 2010/2011 Evaluation Committee Meeting held on 23<sup>rd</sup> August 2010: "Subject to the <u>availability of funds</u> it is recommended that the tender for: Musong Road 1 be awarded to Nucon Roads & Civils / Sphamandla JV to the amount of R 17 093 970.54; and Musong Road 2 be awarded to Nucon Roads & Civils / Sphamandla JV to the amount of R 22 363 190.76."

During discussions with the Department of Roads & Public Works (the funder of the project) the following was agreed upon:

• That Musong Road No.2 project not be awarded due to extreme budget shortfall and that this part of the contract be cancelled formally through news papers;

- That Musong Road No.1 project be awarded but extended by an additional 1.9 to 2 km in length in order to achieve surfacing from Tele bridge border post, through the mountain pass up to the single carriage bridge at the end of the pass. The department approves that negotiations be held with the successful contractor for Musong Road No 1 in order to also construct the additional distance of 2km through the mountain pass;
- The revised budget of the reduced scope of works (approximately 73% of original works) is acceptable if one compares it to the engineer's estimate of R 27m. Should the negotiations with the contractor not exceed this amount, the Department accepts the revised contract amount;
- The department will not finance the remainder of the road;
- The cash flows of the contractor would have to match the available funding (R 21m) with the remainder to be paid by end April 2011.

At a meeting held on the 10<sup>th</sup> September 2010 – present F Swanepoel (Dibanani Consulting); R Crozier & P Brooks (Senqu Municipality) W J Cronje (Nucon) and P Christensen (Sphamandla Woman Construction) the following was agreed:

- That the contract can be extended with +/- 1.5km at the tendered rates;
- That the amount for P&G items as per attached bill of quantities be accepted;
- To an additional savings of R 50 000 that can be used to construct an additional length of road at the contract rates;
- To an additional two (2) months to complete the work i.e. total contract period of ten (10) months; and
- To extend the tender validity period to 25/09/2010.
